WEBSITE TERMS AND CONDITIONS

IN TERMS OF SECTION 11(3) OF THE ELECTRONIC COMMUNICATIONS AND TRANSACTIONS (ECT) ACT 25 OF 2002, THESE TERMS AND CONDITIONS ARE BINDING AND ENFORCEABLE AGAINST ALL PERSONS THAT ACCESS THE JHC WEBSITE OR ANY PART THEREOF.

IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS YOU MUST LEAVE THE JHC WEBSITE IMMEDIATELY, AS FURTHER USE WILL AUTOMATICALLY BIND YOU TO THESE TERMS AND CONDITIONS.

DEFINITIONS AND INTERPRETATION

- "JHC" means the Johannesburg Housing Company, a Non-Profit Company, including its subsidiaries and business units is incorporated under section 21 of the Companies Act 71 of 2008.
- "JHC website" means the Johannesburg Housing Company NPC website located at www.jhc.co.za and includes any part or element thereof;
- "User" means any person who enters or uses the JHC website, notwithstanding the fact that such a person only visited the home page of the JHC website;
- References herein to the singular include the plural and vice versa; and
- Notwithstanding the fact that hyperlinks in these terms and conditions to copyright notices and legislation should be deemed part of these terms and conditions in terms of section 11 of the ECT Act, the fact that some or all of the hyperlinks may be non-operational, shall not play a role in determination of the validity and interpretation of these terms and conditions.

1. GENERAL

JHC is a Non-Profit Company and an accredited Social Housing Institution in terms of the Social Housing Act (No. 16 of 2008).

2. ALLOWED USE AND LICENSE

- 2.1 JHC licenses the User to view, download and print the content of JHC's website, provided that such content is used for personal, educational and/or non-commercial purposes only;
- 2.2 Content from JHC's website shall not be used or exploited by Users for any commercial and non-private purposes;
- 2.3 Users may only access and use the JHC website for lawful purposes;
- 2.4 The caching of the JHC website shall only be allowed if:
 - 2.4.1 The purpose of the caching is to make the onward transmission of the content from the JHC website more efficient;
 - 2.4.2 The cached content is not modified in any manner whatsoever;
 - 2.4.3 The cached content is updated at least every 12 (twelve) hours; and
 - 2.4.4 The cached content is removed or updated when so required by JHC.
- 2.5 If any User uses content from the JHC website in breach of the provisions detailed herein:
 - 2.5.1 JHC reserves the right to claim damages from the User;
 - 2.5.2 JHC reserves the right to institute criminal proceedings against the User; and
 - 2.5.3 JHC shall not be liable, in any manner whatsoever, for any damage, loss or liability that resulted from the use of such content by the User or any third party who obtained any content from the User.
- 2.6 Hyperlinks to the JHC website from any other source shall be directed at the home page of the JHC website. JHC shall not be liable, in any manner whatsoever, for any damage, loss or liability that resulted from the use of content from the JHC website, if such content was accessed through a hyperlink not directed at the home page of the JHC website. Persons that wish to link to content beyond the home page of JHC's website shall do so at their own risk and indemnify JHC against any loss, liability or damage that may result from the use of content from the JHC website, if such content was accessed through a hyperlink not directed at the home page of the JHC website;
- 2.7 No person may frame JHC's website, in any manner whatsoever, without the prior written consent of JHC;
- Apart from bona-fide search engine operators and use of the search facility provided on the JHC website by Users, no person may use or attempt to use any technology or applications (including web crawlers or web spiders) to search or copy content from the JHC website for any purposes, without the prior written consent of JHC; and
- 2.9 All licenses and/or permissions granted in terms of this clause 2 are provided on a non-exclusive and non-transferable basis and may be terminated or cancelled by JHC at any time without giving reasons therefore.

3. INTELLECTUAL PROPERTY RIGHTS AND DOMAIN NAME USE

All intellectual property on the JHC website, including but not limited to content, trademarks, domain names, patents, design elements, software, databases, text, graphics, icons and hyperlinks are the property of or licensed to the JHC and as such, are protected from infringement by domestic and international legislation and treaties. Subject to the rights licensed to the User in clause 2, all other rights to intellectual property on the JHC website are expressly reserved.

4. SOFTWARE AND EQUIPMENT

It is the responsibility of the User to acquire and maintain, at his/her own expense, the computer hardware, software, lines and access accounts required to access the Internet and the JHC website and/or download content from this website.

- 5.15 **Alternative dispute resolution**: Subject to urgent and/or interim relief, all disputes regarding:
 - 5.15.1 access to the JHC website:
 - 5.15.2 the inability to access the JHC website;
 - 5.15.3 the services and content available from the JHC website; or
 - 5.15.4 these terms and conditions,

shall be referred to arbitration in terms of the <u>expedited rules</u> of the Arbitration Foundation of South Africa and such arbitration proceedings shall be conducted in Johannesburg in English. The arbitration ruling shall be final and the unsuccessful party shall pay the costs of the successful party on a scale as between attorney and own client.

- 5.16 The costs associated with the access and use of the JHC website are as follows: Free;
- 5.17 **Cooling-off period:** In terms of the operation of section 42(1)(d) of the ECT Act, the cooling-off provisions of the ECT Act do not apply to this web site; and

- 8.2 JHC is under no legal duty to encrypt any content or communications from and to the JHC website and is also under no legal duty to provide digital authentication of any page on the JHC website:
- 8.3 Users may not deliver or attempt to deliver, whether on purpose or negligently, any damaging code, such as computer viruses, to the JHC website or the server and computer network that support the JHC website;

- 9.1 Subject to the provisions of sections 43(5) and 43(6) of the ECT Act, if applicable, and as far as allowed by law, JHC (including its directors, employees, suppliers, Internet service providers, partners, affiliates and agents) shall not be liable for any damage, loss or liability of any nature incurred by whomever and resulting from:
 - 9.1.1 access to the JHC website;
 - 9.1.2 access to websites linked to the JHC website;
 - 9.1.3 inability to access the JHC website;



- 9.1.4 inability to access websites linked to the JHC website;
- 9.1.5 content available on the JHC website;
- 9.1.6 services available from the JHC website;
- 9.1.7 downloads and use of content from the JHC website; or
- 9.1.8 any other reason not directly related to JHC's gross negligence.

JHC shall take all reasonable steps to ensure the quality and accuracy of content available from the JHC website and encourages Users to report incorrect and untrue information subject to the right of JHC to rely on its free expression rights and determine, in its sole and absolute discretion, the contents of this website; and

- 11.2 The User agrees and acknowledges that the consent provided by the User in clause 12.1 satisfies the "writing" requirement as detailed in the ECT Act and the RIC Act.

12. ENTIRE AGREEMENT AND SEVERABILITY

- 12.1 Any failure by JHC to exercise or enforce any right or provision shall in no way constitute a waiver of such right or provision; and
- In the event that any term or condition detailed herein is found unenforceable or invalid for any reason, such term(s) or condition(s) shall be severable from the remaining terms and conditions. The remaining terms and conditions shall remain enforceable and applicable.

13. APPLICABLE AND GOVERNING LAW

Subject to clause 5.4, the JHC website is hosted, controlled and operated from the Republic of South Africa and therefore the South African law enforced by the South African courts governs the use or inability to use the JHC website, its content, services and these terms and conditions.

14. LEGAL COSTS

JHC shall not be liable for costs incurred by Users to obtain professional advice relating to these terms and conditions.
